

# DIALOGUE ON ARGENTINIAN PRISONS

## Introduction to Tumbergencia

My name is Deepan Budlakoti, and I am a former prisoner in Canada who is currently stateless. I am actively participating in a research initiative known as the Prison Transparency Project, where I contribute my insights and experiences as a researcher. The Prison Transparency Project is an extensive seven-year endeavor that conducts a collaborative and comparative study of prison transparency across seven research sites located in Canada, Argentina, and Spain. This project seeks to scrutinize both formal mechanisms and informal practices that facilitate the exchange of information in and out of carceral institutions. Our goals are twofold: to enhance accountability for prison conditions and to safeguard the rights and freedoms of individuals who are incarcerated.

This dialogue stems from a collective of voices, including individuals currently held in custody, university students, and those who have been released from incarceration in Argentina, all under the auspices of the *Tumbergencia* initiative. The collection consists of a variety of short writings, encompassing essays, personal reflections, traditional prison journals, and poetry. Each piece provides a unique angle on the prison experience, offering a lens through which to compare and contrast the conditions and challenges faced in these countries with those experienced in Canada.

When we examine the submissions from Argentina, we can draw valuable comparisons to the prison experiences in Canada. These comparisons may include:

1. **Conditions of Incarceration:** The submissions may illuminate significant differences in living conditions within prisons, such as the extent of overcrowding, the quality of sanitation facilities, and access to essential healthcare services.
2. **Legal Frameworks and Rights:** The writings may delve into the application (or lack thereof) of legal protections for prisoners, with particular reference to the Mandela Rules. These reflections can highlight variations in the treatment of incarcerated individuals,

demonstrating how legal safeguards are either upheld or disregarded across different jurisdictions.

3. **Cultural and Societal Perspectives:** The submissions may shed light on how cultural attitudes toward crime and punishment significantly influence the policies surrounding rehabilitation programs and societal reintegration efforts for individuals after release. The prevailing societal beliefs in each country can shape the support systems available to formerly incarcerated individuals.
4. **Political Context:** Each country's political environment and the corresponding impact of governmental policies on prison conditions can be analyzed, revealing how political changes—such as shifts in leadership, public sentiment, and legislation—affect the management of prisons and the treatment of prisoners. These contributions offer rich, firsthand narratives that illuminate not only the unique experiences within each prison system but also broader social and political issues that intersect with incarceration. They reflect the rapid political changes that can significantly influence prison dynamics and the lives of incarcerated individuals.

As you engage with these writings, I encourage you to reflect on the stark differences in the liberties afforded to incarcerated individuals across different countries, as well as the relevance of international legal standards, such as the *Mandela Rules*, in shaping humane treatment in prison environments.
